## Timeline Narrative of Events and Disclosures on META Subscription to BSC

October 5, 2016 - BSC signed with META (formerly known as "Vintage Engineering Public Company LTD.) a Memorandum of Agreement (MOA) where META agreed to subscribe to a total of 435,658 699 shares in BSC. (corporate disclosure number C05685-2016)

December 20, 2016 – various amendments and disclosures were subsequently made in relation to the executed MOA. In particular was the Dec 20, 2016 disclosure indicating the amendment of the MOA with regard to the long-stop date from December 31, 2016 to January 31, 2017. (corporate disclosure number C07075-2016)

February 15, 2017 – BSC disclosed that it had recently signed an Agreement for the Subscription of Shares of Stock with META for a total of 435,658 699 shares <u>in tranches</u>. (corporate disclosure number C00809-2017)

February 27, 2017 - BSC and META had signed a Subscription Agreement whereby BSC shall issue 43,565,870 shares (Tranche 1) to META with the balance of 392,092,829 shares to be covered by another subscription agreement and payments. (corporate disclosure number C01075-2017)

April 11, 2018 - BSC further issued 104,816,332 shares (Tranche 2 A) to META on February 8, 2018 which represent partial payment of Tranche 2 and was disclosed by BSC through Form 4-11. As of this date the balance of the subscription of META as per the MOA dated October 5, 2016 is 287,276,497 shares. (corporate disclosure number C02299-2018)

October 1, 2018 – BSC issued to META 106,892,000 shares (Tranche 2 B) and was disclosed by BSC through from 4-11. As of this date the balance of the subscription of META as per MOA dated October 5, 2016 is **180,384,497** shares. (corporate disclosure number C06526-2018)

October 6 & November 15, 2021 – META had fully paid for its subscription on the remaining 180,384,497 shares prompting BSC to now file the disclosure form 4-11 to reflect the change in number of issued and/or outstanding shares of the Company brought about by this event.
