We reply to your email- letter dated today, on the subject matter of news article appearing at Manila Standard Today last November 2, 2013, which we quote:

"BASIC Energy Corp. is keen on pursuing the development of the West Bulusan geothermal power project in Sorsogon province, once it obtains government's permits, a company executive said.

Basic Energy president Oscar de Venecia, Jr. said the company's application was still under

review by the Energy Department. The generation capacity of West Bulusan geothermal project has yet to be determined, he said.

De Venecia said once successful exploration and steam resource was determined, Basic Energy would put up a power plant in Batangas.

De Venecia said Basic Energy would also develop a mini-hydro project in Negros Occidental that could deliver up to 25 MW.

The company submitted applications for 10 frontier areas for hydro development."
