Clarification of News Report

We wish to confirm the news item published in The Standard (Internet Edition) on July 25, 2016.

The article reported in part that:

"The consortium of Basic Energy Corp. and Trans-Asia Oil and Energy Development Corp. is on track to complete the drilling of Mabini geothermal power project in Batangas by September.

. . .

'Results are projected by mid-September assuming are all go according to plan,' Basic Energy senior vice president Anthony Cuaycong said.

Cuaycong said drilling was projected to reach 78 days from spud date of June 15.

. . .

The company also allocated P150 million for capital expenditure this year, bulk of which are for the geothermal drilling operations in Mabini, Batangas.

In this regard, based on the work program for the drilling of an exploratory well in the Mabini Geothermal project, and considering the current progress of the drilling operations, it is expected that the target depth of 1,500 meters will be reached on or about the middle of September, 2016, which should be about 78 days from the June 15, 2016 spud date. We also confirm the budget of Php150 Million for the various projects of the Company, the bulk of which is allocated to this Mabini Geothermal project.
