The Board of Directors Mabini Energy Corporation, a wholly owned subsidiary of Basic Energy Corporation, in its meeting on February 9, 2021, approved the principal terms of the pro-forma Wind Energy Service Contract (WESC) with the Department of Energy (DOE) covering a targeted 50 MW wind energy project in the Mabini Peninsula, Mabini,Batangas, that will expand over 4,860 hectares of land in the said peninsula, and authorizing the President of the Company, Oscar L. de Venecia, Jr., to sign the WESC.The pro-forma WESC provides for a non-extendible five (5) years pre-development stage and a twenty-five (25) years development stage, counted from contract signing, which is extendible for another twenty-five (25) years, subject to DOE approval.		
The Board of Directors of Basic Energy Corporation, the parent company of MEC, in its meeting held on February 9, 2021, after the MEC Board Meeting, ratified the aforementioned approvals by MEC.
