During this period, the Company has conducted the necessary geological and geophysical studies to determine the potential of the geothermal resource and information and education campaign in the affected areas. As the Company encountered difficulties in securing clearances from the indigenous people (IPs) in the communities involved, the Company requested the DOE on January 8, 2018 for a suspension of obligations, until it has addressed issues raised by the IPs. After more than fifteen (15) months, the DOE, finally acted on the Company's request for suspension of obligations ruling that the non-completion of the pre-development phase of the project was not due to force majeure and terminated the service contract retroactive February 8, 2018.

In the same manner, BEC also received from the DOE, a letter denying the request for moratorium for Geothermal Service Contract (GSC) No. 2013-11-048 covering West Bulusan Geothermal Project, which was filed by the Company as early as October 26, 2016, due to the strong opposition of the local communities and the Diocese of Sorsogon.
